The FAC utilized Operating Guidelines previously, which provided a set of procedures that were generally followed. Staff has edited and added to these guidelines to create a set of Bylaws that provide more detail of meeting operation and attendance, membership, and officer roles. Additional feedback was included from Committee members at the last meeting, as well as from KTMPO staff prior to this meeting. The new Bylaws are provided in the packet below for Board discussion and approval. Modifications deemed necessary to draft FAC Bylaws are welcomed for discussion and will be incorporated by majority vote.

GUIDELINES AND PURPOSE

The Freight Advisory Committee (FAC) are intended to assist KTMPO staff and Committee members with FAC operation and administration. These will become active upon FAC approval. These guidelines are not intended to act as official Bylaws, but rather acknowledgement of procedures for Committee operation. the regional freight system.

COMMITTEE RESPONSIBILITY

The purpose of FAC is to provide industry expertise and guidance to various entities regarding the regional freight system. FAC will serve to maximize the region's freight capabilities and understanding through

- Sharing information, knowledge, and technology through public and private partnerships;
- Promoting the region's freight capabilities; and
- Supporting and improving the regional freight system

FAC will educate the public and policy officials by promoting freight plans, policies, programs, projects, and partnerships as necessary. FAC responsibilities will include providing advice and guidance regarding freight activities, as well as strategic product and project review to KTMPO and its committees and subcommittees, the Texas Department of Transportation, local governments, KTMPO staff, and the general public.

COMMITTEE MEMBERSHIP

FAC members will be confirmed on an as-needed basis by KTMPO Staff. Committee members may include representatives from local, state, and federal governments, transportation agencies, educational institutions, and private industry. Public-sector members shall be technical or staff level, not elected officials. Private-sector members should possess technical knowledge of freight movements within and through Central Texas.

REQUIREMENTS

Members should be knowledgeable regarding freight industry topics in Central Texas including, but not limited to, logistics, intermodal freight, rail, and air cargo topics. Knowledge of specific freight transportation modes is also desired.

ATTENDANCE

FAC meeting attendance records will be recorded through sign-in sheets. Committee members are encouraged to send a representative if unable to attend.

APPOINTMENT LENGTH

FAC Members will be selected and serve on an as-needed basis.

MEETINGS

The regularly scheduled FAC meeting will generally occur on a quarterly schedule; additional meetings may be scheduled as needed. The FAC meeting agenda will be developed by KTMPO staff in consultation with FAC members. Meetings shall generally be held at KTMPO offices and may be scheduled for off-site locations as warranted. Meetings shall be conducted by KTMPO staff or FAC officers.

QUORUM

Thirty three (33%) of the membership will constitute a quorum.

VOTING

From time to time, Committee members may be asked to vote on a certain topic. Representatives shall be permitted to vote on members' behalf. Members or member representatives present shall constitute a quorum for action. Committee business may be accomplished by a simple majority vote of the members or representatives in attendance.

ARTICLE I

Name

The name of this committee shall be the Freight Advisory Committee, also referred to as FAC.

GUIDELINES AND Purpose

The Freight Advisory Committee, hereafter referred to as FAC, is established by Bylaws the Killeen-Temple Metropolitan Planning Organization (KTMPO) Transportation Planning Policy Board (TPPB) to provide industry expertise and guidance to various entities regarding the regional freight system.

FAC shall advise the KTMPO in the consideration of <u>policies regarding the operation and</u> administration of the regional freight system, in order to promote cooperation and encourage economic activity.

These Bylaws will become active upon FAC approval. These guidelines are not intended to act as official Bylaws, but rather acknowledgement of procedures for Committee operation.

FAC Responsibilities

The committee will serve to maximize the region's freight capabilities and understanding.

FAC's functions include, but are not limited to, the following:

- Identification and evaluation of existing freight capabilities in the KTMPO region, and adjacent regions that impact freight within the KTMPO planning area;
- Identification of needs and gaps in freight capacity and capabilities;
- Identification of policies, projects, and partnerships that can address needs and gaps;
- Sharing information, knowledge, and technology through public and private partnerships;

- Promoting the region's freight capabilities; and
- Supporting and improving the regional freight system through coordination of project planning, delivery and identification of funding needs and sources.

The FAC will educate the public and policy officials by promoting freight plans, policies, programs, projects, and partnerships as necessary. The FAC² responsibilities will include providing advice and guidance regarding freight activities, as well as strategic product and project review to KTMPO and its committees and subcommittees, the Texas Department of Transportation, local governments, KTMPO staff, and the general public.

COMMITTEE RESPONSIBILITY

The purpose of FAC is to provide industry expertise and guidance to various entities regarding the regional freight system. FAC will serve to maximize the region's freight capabilities and understanding through Sharing information, knowledge, and technology through public and private partnerships;

- Promoting the region's freight capabilities; and
- Supporting and improving the regional freight system through coordination of project planning, delivery and identification of funding needs and sources.

FAC will educate the public and policy officials by promoting freight plans, policies, programs, projects, and partnerships as necessary. FAC responsibilities will include providing advice and guidance regarding freight activities, as well as strategic product and project review to KTMPO and its committees and subcommittees, the Texas Department of Transportation, local governments, KTMPO staff, and the general public.

COMMITTEE Membership

FAC members will be confirmed on an as-needed basis by the FAC. There is a limit of 20 members The voting membership of the FAC shall be limited to 20 members representing freight interests and be representative of the area within the KTMPO boundary, and areas impacted by or which impact freight within KTMPO boundaries. Committee members may be from stakeholder groups which include, but are not limited to:

- Staff from Cities within the KTMPO Region, the CTCOG Rural Planning Organization (RPO), and adjacent Counties;
- Staff from Counties within the KTMPO Region, the CTCOG RPO, and adjacent Counties;
- Freight shipping providers;
- Companies, corporations, and non-profit organizations in industries related to or which involve freight;
- Transportation agencies;

- KTMPO Transportation Planning Policy Board (TPPB) and Technical Advisory Committee (TAC) members; and
- Educational institutions

Private-sector members should possess technical knowledge of freight movements within and through Central Texas. Membership will not be limited in any of these categories, but the FAC will place an emphasis on recruiting members from the freight industry.

Nomination Process

The nomination process for FAC membership will be as follows:

- The initial voting members shall be appointed in writing by entities represented on the KTMPO TPPB.
- <u>Stakeholder organizations desiring a voting position on FAC may submit a written</u> request to the chairperson or KTMPO staff member identifying the individual proposed to represent their organization's freight interests on FAC.
- Individual stakeholders desiring a voting position on FAC may submit a written request to the chairperson or KTMPO staff member identifying their transportation interest on FAC.
- The voting FAC members will consider each nomination; approval of nomination requires a majority vote with a quorum present.
- Voting members may, in writing, appoint an alternate to vote in their stead and be counted for quorum purposes.
- Written requests may be done in the form of an email from a stakeholder organization representative, or a letter document.
- Members should be knowledgeable regarding freight industry topics in Central Texas including, but not limited to, logistics, intermodal freight, rail, and air cargo topics. Knowledge of specific freight transportation modes is also desired.

Terms

Voting members shall serve until they resign, or someone is appointed in their place. The written request must also indicate that the organization will commit to maintaining a representative on the Committee in case the current member representative resigns/is removed from their position at the organization. The organization will indicate that they will submit written requests for a new representative on the Committee unless it requests to be removed from the Committee.

Ex-Officio Members

Ex-officio members shall act as a guide to the FAC. Ex-officio membership may be requested in writing, approved by the Committee, and ratified by the KTMPO TPPB. Ex-officio members do not hold any voting rights.

Non-Discriminatory

There shall be no discrimination in any respect in selection of members or any activity of the FAC due to race, color, sex, religion, handicap/disability, age, or national origin.

Meetings

A. Frequency

The FAC shall meet quarterly or more frequently as needed.

B-A. Meetings Notices

KTMPO staff will be responsible for all meeting notices and publicity. Specifics of the meeting will be provided to each FAC member in writing and to the general public in accordance with the provisions of the Texas Open Meetings Act. The FAC members will be notified of all meetings at least three (3) days prior to the meeting, other than emergency meetings which will be called in accordance with the Open Meetings Act.

G.B. Meeting Facilities

It will be the responsibility of KTMPO staff to make arrangements for the meeting place.

D.C. Date and Time of Meetings

It will be the responsibility of KTMPO staff to poll the FAC membership to select a date and time for the meeting that will be convenient for the majority of members.

The regularly scheduled FAC meeting will generally occur on a quarterly schedule; additional meetings may be scheduled as needed. The FAC meeting agenda will be developed by KTMPO staff in consultation with FAC members. Meetings shall generally be held at KTMPO offices and may be scheduled for off-site locations as warranted. A virtual/call in option shall be available for all meetings. Any Committee member that attends online with their camera on will be counted as present towards quorum. Meetings shall be conducted by KTMPO staff or FAC officers.

E.D. Minutes

KTMPO staff shall record and maintain attendance records and minutes of FAC meetings.

F.E. Video/Teleconferencing

Any committee member may telephone or may-videoconference into meetings and are be considered "present" and are counted toward the making of a quorumfor the purposes of a quorum if they are visible on camera and have working audio equipment, per Open Meetings Act requirements. They may also discuss and vote on any item so brought before the committee.

G.F. Attendance

Failure to attend **three (3)** consecutive meetings of the committee physically or via videoconference, without notice or the attendance of a proxy, shall constitute a resignation from the FAC.

Meeting attendance records will be recorded through meeting minutes and sign-in sheets. Committee members are encouraged to send a representative if unable to attend. A warning letter will be sent out to Committee members who have missed two consecutive meetings.

Quorum

Thirty three (33%) of the membership will constitute a quorum.

VOTING

From time to time, Committee members may be asked to vote on a certain topic. Representatives shall be permitted to vote on members' behalf if selected in writing ahead of the meeting. Members or member representatives present shall constitute a quorum for action. Committee business may be accomplished by a simple majority vote of the members or representatives in attendance.

Secretarial Functions

Term of Office

Texas Truck Congestion Analysis Tool (TCAT)

Analysis tool based on INRIX Speed Data and Local Traffic Volumes

Overview

- Planning tool for analyzing and monitoring congestion, primarily focused on truck congestion and roadway performance
- Main goal: get map-based roadway performance data into the hands of those who need it
 - No license, registration fees
 - No specific GIS skills required
 - Accessible by all those who have the link



What Can TCAT Be Used For?

- Regional/Geographical analysis
- Corridor Analysis
 - Custom
 - Pre-defined
- Texas Top 100 Bottlenecks Trucks
- Visualizing Context Information
 - Projects from the TxDOT Unified Transportation Program (UTP)
 - Freight infrastructure, truck trip generators
- Monitoring parts of the Texas freight network
- Other uses

Underlying Data – Texas 100 Database


- Produced as part of the Texas 100 Most Congested Roadways effort between TTI and TxDOT
- Covers most roadways non-local roads in Texas
 - Over 241,000 road segments covering 106,000 + centerline miles of roadway across the state
 - One subset is the 10,000 + centerline miles monitored in the Texas 100 list
- Multiple years of data (2016 through 2020)

Underlying Data – Texas 100 Database

- Contains traditional mobility performance measures on annual basis for both all-vehicle and truck-only
 - Delay
 - Delay per mile
 - Congestion cost
 - Travel time index
 - Planning time index
 - Others

Underlying Data – Texas 100 Database

- All measures are stored on agency's network (RHiNo) at the road segment level
 - Flexibility in creating custom corridors
 - Provides for better relationships to other RHiNo road segment characteristics and other agency datasets
 - Sections can be saved and monitored from year-to-year
 - If speed data is not available, speeds are estimated from like segments
- All measures are speed and volume-based:
 - INRIX speed data
 - XD network conflated to RHiNo INRIX speed data associated to RHiNo
 - RHiNo network
 - Provides roadway geometry, traffic volumes










TCAT – Example Custom Corridor







UTP Projects


- Visualize projects from TxDOT's Unified Transportation Program (UTP)

- Projects are separated into 4 categories:
 - Underway or begins soon
 - · Begins within 4 years
 - · Begins in 5 to 10 years
 - Corridor Studies, construction in 10+ years



Visualize Context Information

- Allow users to visualize various activities that may impact roadway performance.
- Truck trip generators Energy sector information (sand mines, oil disposal wells), Border crossings, Truck Parking

 Map orientation can be changed to dynamically view the area from different perspectives




Monitored Roadways

- Built using the freight network, based on truck AADT changes, type of road.
- Multiple RHiNo segments for each monitored roadway.
- Can add new monitored sections or change extent of sections as needed.
- Can view individual road segments, trend line, and show on map.



- Extension of performance measure summaries
- Provides quick access to both interactive and printable (pdf and images for presentations) summary reports
- Available for all geographies/regions included in TCAT







NOTE: Truck vehicle hours of delay can be calculated by dividing truck person-hours of delay by 1.14



Changes in congestion are primarily due to two key parameters: speeds and volumes (shown to the left and right). Slight changes in speed would indicate the volume change is driving the change in congestion. Conversely, a slight change in volumes would indicate the change in speed is driving the change in congestion. For the purpose of this report card, VMI was used to represent the traffic volumes to capture any changes in the roadway segmentation.

Future Updates/Enhancements

- Quarterly truck mobility reports similar to annual report cards but more frequent, allowing for seasonal and cross-year comparisons
- Crash risk analysis
 - All crash risk in future truck only
 - Uses Safety Performance functions built from real data across the state and applied back to locations based on the location's road characteristics
 - For example, if location has higher crashes than the benchmark for that type road (number of lanes, AADT, functional class), could be a "red" spot for potential crash risk and further evaluation.
- Truck origin-destination/select link analysis for truck top 100 congested roadways to better understand truck travel patterns on those congested roadways – yearly using INRIX trips and INRIX trajectory data
