

Meeting Minutes:

- 1. Call to Order: Uryan Nelson called the meeting to order at 9:34 a.m.
- 2. Opportunity for Public Comment: No comments were made by the public.

3. Staff Update: Meeting Schedule; Other Updates; Air Quality.

Uryan Nelson informed the TAC of upcoming KTMPO meetings through November. Mr. Nelson gave a brief update presentation on the 2023 UTP. Mr. Nelson updated the group on KTMPO's Federal Certification Review, and the FY23-26 TIP status. Mr. Nelson reminded the TAC that Officer elections for Policy Board would be conducted at the Policy Board meeting on September 21st, 2022. Mr. Nelson updated the TAC on the Safe Streets for All Grant and the Bell County Thoroughfare Plan Update. Mr. Nelson mentioned the Greenhouse Gas Performance Measures discussed at the AMPO meeting. James McGill informed the TAC of funding opportunities, PROTECT Program focused on resilience, CRISI focused on rail infrastructure and safety, and the TxDOT Transportation Alternatives (TA) call for projects opening in October. Mr. Nelson mentioned the possible tour of the Texas A&M Rellis Campus on November 9th. Maximum ozone air quality readings for the month of August were 65 parts per billion (ppb) at the Temple station and 67 ppb at the Killeen station.

4. Action Item: Approve minutes from the August 3, 2022, meeting.

Kristina Ramirez made a motion to approve the August 3, 2022, meeting minutes, seconded by Jason Deckman; the motion passed unanimously.

5. Discussion and Action Item: Regarding the KTMPO TAC and Policy Board Meeting Schedule for FY2023

Uryan Nelson presented the proposed FY2023 meeting schedule for TAC and Policy Board. Mr. Nelson stated that two of the TAC meetings in the months of January and July have been moved back one week due to holidays. Mr. Nelson also noted that if state or national meetings require meeting dates to shift, staff will request the Policy Board to change the schedule and inform the TAC members.

Bobby Lewis made a motion to recommend approval of the KTMPO TAC and Policy Board meeting schedule for FY2023, seconded by Judge Roger Miller; the motion passed unanimously.

6. Discussion and Action Item: Regarding Resolution 2022-09 Supporting October 2022 as Walk to School Month and October 12, 2022 as Walk to School Day.

James McGill provided a history of October being walk to school month. Mr. McGill commented that KTMPO wants to support any events for walk to school day, creating an awareness for walking infrastructure and safety.

Jason Deckman made a motion to recommend approval of the KTMPO TAC and Policy Board meeting schedule for FY2023, seconded by Kristina Ramirez; the motion passed unanimously.

7. Discussion and Action Item: Regarding Resolution 2022-10 Providing Guidance on Addressing KTMPO Project Inflation Requests

Uryan Nelson provided a brief review of staff efforts to provide guidance on project funding requests due to inflation. Mr. Nelson stated that staff decided a resolution clarifying STIP administrative amendment requirements and restrictions was the best way to provide guidance.

Sam Listi asked where the money would come from to approve the project increase request. Uryan confirmed that the request for increased project funds would come from unallocated MPO funds. Victor Goebel asked what happens to projects when there aren't enough unallocated dollars left. Jason Deckman and Judge Roger Miller commented on the benefits and costs of over or under programming

MPO funds. Judge Roger Miller recommended language change in the resolution to add the words "considered for", in the furthermore, be it resolved section of the resolution.

Judge Roger Miller made a motion to recommend approval of Resolution 2022-10 Providing Guidance on Addressing KTMPO Project Inflation Requests with the changes discussed, seconded by Sam Listi; the motion passed unanimously.

8. Discussion Item: Regarding Presentation on the 2022 Signalization Study findings

Lance Ballard from Kimley-Horn will be presenting a brief overview of the Signalization Study, the finding from their survey of agencies, and their recommendations.

9 Discussion Item: Regarding public input received through August 2022.

James McGill presented two new comments submitted during the month of August. Public comment received on August 13, 2022, concerning the safety of Chaparral Road. Public comment received on August 26, 2022, regarding construction on Business 190, in Copperas Cove.

FY23-26 TIP and 2045 MTP Amendments

TIP Background

The Transportation Improvement Program (TIP) is a 4-year transportation planning document that includes a detailed listing of projects reasonably expected to begin within a four-year period. The current TIP covers FY21-FY24 and a proposed TIP undergoing review covers FY23-26. Projects included in the TIP must be consistent with the MTP and are chosen based on regional priority and available funding. An amendment to a TIP is not completed until the change has also been included in the STIP—Statewide Transportation Improvement Program.

MTP Background

The Metropolitan Transportation Plan (MTP) is the 25-year long range planning document for KTMPO. The 2045 MTP includes a short and long-range prioritized project listing incorporating projects expected to be funded within the document's 25-year planning horizon. The project listing is fiscally constrained based on the projected funding the MPO expects to receive in the 25 year planning period. The document also lists regionally significant unfunded projects. Projects must be included in the funded section of the MTP in order to receive state or federal funding.

UPWP Background

The Unified Planning Work Program (UPWP) provides descriptive and scheduling details for the Killeen-Temple Metropolitan Planning Organization (KTMPO) planning process for a two year period. The UPWP serves as a base document for carrying on the continuing, cooperative, and comprehensive transportation planning process in the Killeen-Temple urbanized area. It serves as KTMPO's work plan and identifies tasks and subtasks that staff plan to undertake during the plan period and the associated budget for these tasks.

UPWP Special Studies

Task 5 of the UPWP includes details of special studies funded by the MPO for specific planning activities and initiatives. Several Subtasks under Task 5 contain placeholder slots for future special studies that have not been selected yet. TxDOT and FHWA recently recommended that KTMPO fully describe those placeholder Subtasks instead.

Ideas for potential special studies to be funded in FY2023 include the following:

- Voluntary Resiliency Implementation Plan (RIP)
- Housing Coordination Plan
- Congestion Management Plan Update
- Public Involvement Study
- MPO Boundary Expansion Study

KTMPO has an estimated \$160,000 available in FY2023 to fund new Special Studies.

KTMPO 2022 FCR Draft Report Recommendations

Background

Every four years, the Secretary of the U.S. Department of Transportation (DOT) must certify that each metropolitan planning organization (MPO) serving a transportation management area (TMA) is carrying out the metropolitan planning process in adherence with federal statutes and regulations.

The Federal Transit Administration (FTA) and Federal Highway Administration (FHWA) conduct a review of the metropolitan planning process within each TMA and jointly issue this certification on behalf of the DOT Secretary, in accordance with 49 U.S.C. 5303(k).

Staff Report

FTA and FHWA conducted the required Federal Certification Review (FCR) of KTMPO between May 24-26, 2022. The FCR involved interviews of several Policy Board members, a rigorous review of MPO planning practices with MPO staff, and a public hearing/comment period. FTA and FHWA staff also attended the May 25, 2022 Policy Board meeting.

On October 11, 2022 staff received FHWA and FTA's draft report and will provide a brief update to the TAC on their findings.




