All meetings are scheduled for 9:30am at the Central Texas Council of Governments offices in Belton, Texas, unless otherwise noted (i.e. – electronic meeting).

### b) Other Updates:

- The Texas Delivers 2050 Freight Mobility Plan has been approved by the Texas Transportation Commission and will be submitted to FHWA for final approval. The Plan can be accessed <u>here</u>.
- H.R. 3372, a bill currently in the U.S congress would establish a voluntary pilot program for states to increase truck weights on federal interstates up to 91,000 pounds on six axles. Participating states would issue permits by vehicle or by group of vehicles that would specify acceptable routes and require permit holders to report on accidents and other details. The program would be discontinued after five years, although the Department of Transportation could extend it for another five years.
- H.R. 3318 would increase the maximum weight (a variance of 10% per axle) that a commercial vehicle transporting dry bulk goods can carry on an interstate highway to address the issue of certain cargo (such as flour) that tends to shift en route.
- H.R. 2948 (CARS Act) would require states to allow automobile transporters to operate on interstate highways at increased weights, allowing a 10% weight increase for certain types of auto haulers.
- Bell County Thoroughfare Plan
  - Approved and Adopted by Bell County Commissioners Court on July 17, 2023.
  - The finalized plan is published on the <u>Bell County</u> and <u>KTMPO</u> websites.

#### **Meeting Minutes**

1. Call to Order: The meeting was called to order by Jason Deckman at 2:31 PM.

2. Public Comments: No public comments were made.

**3. Staff Update:** Dominic Elizondo discussed the schedule for upcoming KTMPO meetings, the USDOT Multimodal Project Discretionary Grant Opportunity (MPDG) NOFO, the TCEQ Texas Volkswagen Environmental Mitigation Program (TxVEMP) All Electric Program, Texas H.B. No. 4885 creating the Texas Hydrogen Infrastructure, Vehicle, and Equipment Grant Program, H.B. No. 1846 providing a skills test for commercial learner's permit holders from other states, the FRA's FY23 Railroad Crossing Elimination grant program opening in September, and the Texas Delivers 2050 Freight Mobility Plan being sent to the FHWA for final approval. Maximum ozone air quality readings for the month of March were 67 parts per billion (ppb) at the Temple station and 60 ppb at the Killeen station.

4. Discussion and Action Item: Approve minutes from the April 25, 2023 meeting.

Keith Sledd made a motion to approve the April 25, 2023 meeting minutes, seconded by Elvar Leal; the motion passed unanimously.

#### 5. Discussion Item: Regarding Presentation on Autonomous Vehicles and Freight.

Zeke Reyna, Emerging Technology Portfolio Project Manager at TxDOT, provided a presentation on the future of autonomous vehicles in Texas, with an overview of eight freight companies in Texas operating autonomous vehicles programs with freight, personal delivery vehicles, and neighborhood electric vehicles. Mr. Reyna also discussed the Texas Connected and Autonomous Vehicle task force, which brings together hundreds of freight and vehicle company stakeholders across Texas to coordinate the implementation of an autonomous vehicle network, and TxDOT's Urban Air Mobility Advisory Committee for drone and other aerial AV delivery systems.

Keith Sledd asked if the autonomous freight vehicles were actually hauling cargo and what the battery charging time for the EV vehicles was. Mr. Reyna said that they were hauling freight and that his estimate of the charging time would be six to eight hours for eight to ten batteries. Mr. Sledd then asked how the vehicles were handling the cargo, and Mr. Reyna said that they are being unloaded at transfer stations by humans. Ginger Watkins asked what the price differential was between a traditional and an AV rig. Mr. Reyna said that every one of the AVs would be worth millions of dollars due to the amount of technology on each one, including cameras, sensors, and Lidar. Jason Deckman asked what the rest requirement is for drivers in AVs and if there were any fuel savings. Mr. Reyna said that they would still have the same rest requirements, but the trips taken in AVs are typically shorter intercity routes in the state and that the AVs were still largely diesel trucks that see a fuel savings due to increased efficiency.

6. Discussion Item: Overview of Texas Freight Mobility Plan Policy and Funding Recommendations.

Dominic Elizondo provided an overview of the Texas Freight Mobility Plan's policy, programming, and technology and operations recommendations, as well as the Freight Investment Plan developed from TxDOT's 10-year Unified Transportation Plan (UTP).

6. Discussion Item: Regarding Discussion on Local KTMPO Freight Topics.

Dominic Elizondo asked for committee discussion on any freight needs or gaps in the KTMPO region and possible ways to address them. Mr. Elizondo asked how AVs would affect truck parking needs in the future, and Zeke Reyna said that AVs would not need to stop except for charging. Kara Escajeda said that Nolanville is looking to apply for the Railroad Crossing Elimination Grant when it opens, and that the application would probably get more traction if other cities in the MPO such as those between Rogers and Buckholts that have safety issues at crossings also applied. Jason Deckman asked about the project Nolanville was wrapping up by city hall, and Ms. Escajeda said that it was for regrading a road and making it one way. JR Leal said that Temple and Central Texas Railway was looking for property near railroads such as BNSF or Union Pacific for a loading station for customers that do not have a physical address. Keith Sledd said that Fort Cavazos has received a noncompetitive grant for a containerization study for the potential public-private multimodal transfer station at a joint use railhead in the western portion of the Fort. Jason Deckman said that TxDOT has been working on grade separation at two intersections on loop 363.

7. Discussion Item: Regarding Discussion on Public Input Received Through June 2023.

Two comments were made-one from a Copperas Cove community page on Facebook about the bypass project on US-190, and another on Facebook regarding a narrow bike lane by Mikeska's BBQ which was actually white striping on a frontage road.

#### 8. Member Comments.

There were no member comments.

#### 9. Discuss Possible Agenda Items for Next Meeting on October 24, 2023.

Jason Deckman suggested that a possible agenda item for the next meeting would be a presentation on major TxDOT roadway projects since the call for projects has closed.

# Approval of Proposed Revisions to the FAC Bylaws



#### Approval of Proposed Revisions to the FAC Bylaws.

Staff is proposing revisions to the bylaws to reduce the required FAC meeting frequency to at least two meetings a year rather than quarterly meetings. This is to reduce the burden on freight stakeholders with busy meeting schedules and to allow meetings to be more productive moving forward. The revisions will still allow the FAC to meet more frequently if needed. Additionally, quorum requirements have been updated to 50% plus one per Robert's Rules of Order. The bylaws with the highlighted changes are attached in the packet.

## Freight Advisory Committee

By-Laws

## ARTICLE I

#### Name

The name of this committee shall be the Freight Advisory Committee, also referred to as FAC.

#### Purpose

The Freight Advisory Committee, hereafter referred to as FAC, is established by the Killeen-Temple Metropolitan Planning Organization (KTMPO) Transportation Planning Policy Board (TPPB) to provide industry expertise and guidance to various entities regarding the regional freight system. FAC shall advise the KTMPO in the consideration of policies regarding the operation and administration of the regional freight system, in order to promote cooperation and encourage economic activity.

### **FAC Responsibilities**

The committee will serve to maximize the region's freight capabilities and understanding.

FAC's functions include, but are not limited to, the following:

- Identification and evaluation of existing freight capabilities in the KTMPO region, and adjacent regions that impact freight within the KTMPO planning area;
- Identification of needs and gaps in freight capacity and capabilities;
- Identification of policies, projects, and partnerships that can address needs and gaps;
- Sharing information, knowledge, and technology through public and private partnerships;
- Promoting the region's freight capabilities; and
- Supporting and improving the regional freight system through coordination of project planning, delivery and identification of funding needs and sources.

The FAC will educate the public and policy officials by promoting freight plans, policies, programs, projects, and partnerships as necessary. The FAC responsibilities will include providing advice and guidance regarding freight activities, as well as strategic product and project review to KTMPO and its committees and subcommittees, the Texas Department of Transportation, local governments, KTMPO staff, and the general public.

### Membership

FAC members will be confirmed on an as-needed basis by the FAC. The voting membership of the FAC shall be limited to 20 members representing freight interests and be representative of the area within the KTMPO boundary, and areas impacted by or which impact freight within KTMPO boundaries. Committee members may be from stakeholder groups which include, but are not limited to:

- Staff from Cities within the KTMPO Region, the CTCOG Rural Planning Organization (RPO), and adjacent Counties;
- Staff from Counties within the KTMPO Region, the CTCOG RPO, and adjacent Counties;
- Freight shipping providers;
- Companies, corporations, and non-profit organizations in industries related to or which involve freight;
- Transportation agencies;
- KTMPO Transportation Planning Policy Board (TPPB) and Technical Advisory Committee (TAC) members; and
- Educational institutions

Private-sector members should possess technical knowledge of freight movements within and through Central Texas. Membership will not be limited in any of these categories, but the FAC will place an emphasis on recruiting members from the freight industry.

#### **Nomination Process**

The nomination process for FAC membership will be as follows:

- Stakeholder organizations desiring a voting position on FAC may submit a written request to the chairperson or KTMPO staff member identifying the individual proposed to represent their organization's freight interests on FAC.
- Individual stakeholders desiring a voting position on FAC may submit a written request to the chairperson or KTMPO staff member identifying their transportation interest on FAC.
- The voting FAC members will consider each nomination; approval of nomination requires a majority vote with a quorum present.

- Voting members may, in writing, appoint an alternate to vote in their stead and be counted for quorum purposes.
- Written requests may be done in the form of an email from a stakeholder organization representative, or a letter document.
- Members should be knowledgeable regarding freight industry topics in Central Texas including, but not limited to, logistics, intermodal freight, rail, and air cargo topics. Knowledge of specific freight transportation modes is also desired.

### Terms

Voting members shall serve until they resign, or someone is appointed in their place. The written request must also indicate that the organization will commit to maintaining a representative on the Committee in case the current member representative resigns/is removed from their position at the organization. The organization will indicate that they will submit written requests for a new representative on the Committee unless it requests to be removed from the Committee.

### **Ex-Officio Members**

Ex-officio members shall act as a guide to the FAC. Ex-officio membership may be requested in writing, approved by the Committee, and ratified by the KTMPO TPPB. Ex-officio members do not hold any voting rights.

#### **Non-Discriminatory**

There shall be no discrimination in any respect in selection of members or any activity of the FAC due to race, color, sex, religion, handicap/disability, age, or national origin.

### Meetings

A. Frequency

The FAC shall meet quarterly twice a year or more frequently as needed.

### A.B. Meetings Notices

KTMPO staff will be responsible for all meeting notices and publicity. Specifics of the meeting will be provided to each FAC member in writing and to the general public in accordance with the provisions of the Texas Open Meetings Act. The FAC members

will be notified of all meetings at least three (3) days prior to the meeting, other than emergency meetings which will be called in accordance with the Open Meetings Act.

### B.C. Meeting Facilities

It will be the responsibility of KTMPO staff to make arrangements for the meeting place.

### C.D. Date and Time of Meetings

It will be the responsibility of KTMPO staff to poll the FAC membership to select a date and time for the meeting that will be convenient for the majority of members.

The regularly scheduled FAC meeting will generally occur on a quarterly schedule; additional meetings may be scheduled as needed. The FAC meeting agenda will be developed by KTMPO staff in consultation with FAC members. Meetings shall generally be held at KTMPO offices and may be scheduled for off-site locations as warranted. Meetings shall be conducted by KTMPO staff or FAC officers.

### D.E. Minutes

KTMPO staff shall record and maintain attendance records and minutes of FAC meetings.

### E.F. Video/Teleconferencing

Any committee member may video conference into meetings and be considered "present" for the purposes of a quorum if they are visible on camera and have working audio equipment, per Open Meetings Act requirements. They may also discuss and vote on any item so brought before the committee.

### F.G. Attendance

Failure to attend **three (3)** consecutive meetings of the committee physically or via videoconference, without notice or the attendance of a proxy, shall constitute a resignation from the FAC.

Meeting attendance records will be recorded through meeting minutes and sign-in sheets. Committee members are encouraged to send a representative if unable to attend. A warning letter will be sent out to Committee members who have missed two consecutive meetings.

#### Quorum

<u>Fifty percent (50%) plus one Thirty three (33%) of the membership voting members or their alternates will constitute a quorum.</u>

### ARTICLE II

#### Officers

### A. Chairperson

The Chairperson shall be chosen by a majority vote of the members present at the <u>election</u> last meeting of the year, and prior to October 1<sup>st</sup> with a quorum established.

The Chairperson shall perform the duties usually assigned to the office, such as:

- Presiding at all FAC meetings;
- Conducting business according to the Bylaws; and
- Performing other appropriate duties

#### B. Vice Chairperson

The Vice Chairperson shall be chosen by a majority vote of the members present at the election with a quorum established. In the absence of, or in the case of the inability of the Chairperson to act, it shall be the duty of the Vice Chairperson to perform all the duties of the Chairperson.

In the absence of both the Chairperson and Vice Chairperson, the FAC members shall designate a member to preside in their absence during the meeting.

### **Secretarial Functions**

The secretarial function shall be performed by a KTMPO staff member. The staff member shall keep the minutes of all Committee meetings and shall perform such other duties as may be needed by the FAC.

#### **Term of Office**

Both the Chairperson and the Vice Chairperson shall serve one (1) year terms, and may not succeed themselves in those offices more than once. The term of office shall run from October 1<sup>st</sup> of the year of election through September 30<sup>th</sup> of the following year.

### Term of Office

Both the Chairperson and the Vice Chairperson shall serve one (1) year terms and may not succeed themselves in those offices more than once. The term of office shall run from October 1<sup>st</sup> of the year of the election through September 30<sup>th</sup> of the following year.

### Time of Election

The officer election will be held at the October meeting every year.

### **Special Elections**

In the event that the Chairperson is unable to serve, the Vice Chairperson shall assume the office of Chairperson and call a special election at the next regular or special meeting to fill the office of Vice Chairperson for the remaining portion of the term. Should the Vice Chairperson be unable to serve, the Chairperson shall call a special election at the next regular, special or Annual Mmeeting to fill the office of Vice Chairperson for the remaining portion of the term. If both the Chairperson and Vice Chairperson are unable to serve, the MPO Director or his/her designee shall call a special election at the next regular, special or Annual Mmeeting to fill these vacancies for the remaining portion of the term.

#### ARTICLE III

#### Amendments

These bylaws may be amended by a majority vote of the FAC membership present at a FAC meeting, provided that official notice of the proposed amendment is included in the agenda packets in advance of the scheduled meeting and a quorum is established.

# Election of New FAC Chair and Vice Chair



#### **Election of New FAC Chair and Vice Chair**

The FAC bylaws provide for the committee Chair and Vice Chair to serve one-year terms on an October-September fiscal year. At the end of this period, the committee will nominate and vote on a new Chair and Vice Chair. Members currently in these roles are allowed to serve no more than two terms. The revisions to the bylaws now have the officer elections held at every October meeting and have updated the roles for Chair and Vice Chair to include exofficio and voting duties. A section regarding special elections in the event the Chair or Voice Chair The roles are outlined below.

#### A. Chairperson

The Chairperson shall be chosen by a majority vote of the members present at the election with a quorum established. The Chairperson shall perform the duties usually assigned to the office, such as:

- Presiding at all FAC meetings;
- Conducting business according to the Bylaws; and
- Performing other appropriate duties

#### B. Vice Chairperson

The Vice Chairperson shall be chosen by a majority vote of the members present at the election with a quorum established. In the absence of, or in the case of the inability of the Chairperson to act, it shall be the duty of the Vice Chairperson to perform all the duties of the Chairperson.

In the absence of both the Chairperson and Vice Chairperson, the FAC members shall designate a member to preside in their absence during the meeting.

#### Special Elections

In the event that the Chairperson is unable to serve, the Vice Chairperson shall assume the office of Chairperson and call a special election at the next regular meeting to fill the office of Vice Chairperson for the remaining portion of the term. Should the Vice Chairperson be unable to serve, the Chairperson shall call a special election at the next regular meeting to fill the office of Vice Chairperson for the remaining portion of the term. If both the Chairperson and Vice Chairperson are unable to serve, the MPO Director or his/her designee shall call a special election at the next regular meeting portion of the term.
